




















Over last year, media reported on several examples of disciplinary proceedings launched against judges of the common courts in Poland. In all of these cases, the disciplinary proceedings are launched against judges and prosecutors who were vocal critics of the reform of the judiciary in Poland or made decisions unfavourable from the perspective of the governing majority.

Protests against the reform of the legal system

The reform of the legal system in Poland "fundamentally violates" all its elements



The independence of the judiciary in Poland has been systematically undermined by the Polish executive and legislative authorities in recent years Proceedings against Poland under Article 258 TFEU were launched by the European Commission in October 2018, alleging infringement of Article 19(1) TEU (the principle of effective judicial protection) together with Article 47 of the EU Charter of Fundamental Rights (the right to a fair hearing and an effective remedy).
